

Articles of Incorporation
Island Trails Network

Article 1: The name of the corporation is Island Trails Network.

Article 2: The period of duration is perpetual.

Article 3: The purposes of the organization are any lawful purpose.

Article 4: Island Trails Network is organized and operated exclusively for charitable purposes within the meaning of section 501 (c)(3) Internal Revenue Code. In addition, Island Trails Network will also meet compliance in all respects with the requirement of the State of Alaska Nonprofit Corporation Act AS 10.20. Notwithstanding any other provision of the articles, Island Trails Network shall not carry on any other activities not permitted to be carried on: (a) by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law); or (b) by an organization contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law). Upon dissolution of the Corporation, assets shall be distributed: (a) to one or more exempt purposes within the meaning of section 501(c)(3) Internal Revenue Code (or the corresponding provision of any future federal tax code); or (b) to the Federal, State and/or local government, for a public purpose. Any such assets not so disposed shall be disposed by the Court of Common Pleas of the Judicial District in which the principal offices of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

Article 5: The physical address of the initial registered office is 2267 Forest Drive Kodiak Alaska 99615. The mailing address of the corporation is PO Box 301 Kodiak Alaska 99615. The name if the initial registered agent is Andy Schroeder.

Article 6: The number of directors constituting the initial board of directors is three. The names and addresses of those persons, each of who shall serve as a director until their successor is elected and qualified, is as follows:
